TO AVOID INTEREST AND PENALTY, PAYMENT MUST BE POSTMARKED BY APRIL 30TH FOR 1ST HALF OR FULL YEAR, AND OCTOBER 31ST FOR 2ND HALF. THIS IS AN ANNUAL BILLING. INTEREST AND PENALTY ON DELINQUENT TAXES ARE CALCULATED ON THE FULL YEAR AMOUNT OF UNPAID TAX FROM THE DATE OF DELINQUENCY UNTIL PAID. (RCW 84.56.020)

INTEREST on delinquent tax is computed monthly from the date of delinquency until payment at twelve percent (12%) per annum as prescribed by law (not prorated). **PENALTY** of three percent (3%) is assessed on the amount of current year tax delinquent on June 1st. An additional penalty of eight percent (8%) is assessed on the total amount of current year tax delinquent on December 1st, as prescribed by law. State law does not allow partial payments. (RCW 84.56.020)

TAXES: \$50.00 or less must be paid in full by April 30th. **NSF CHECK FEE:** \$25.00 processing fee on all NSF checks.

MOBILE HOMES: Check with the Treasurer's office before buying, selling or moving a mobile home to protect your property against any lien. (RCW 84.60.020)

PERSONAL PROPERTY: FULL OR FIRST HALF TAX MUST BE PAID BY APRIL 30TH OR ENTIRE TAX BECOMES DUE, DELINQUENT AND SUBJECT TO SEIZURE AND ADDITIONAL COSTS. When personal property is sold, dissipated or liquidated, the following years tax is PAID IN ADVANCE, AT THE TIME OF THE SALE.

SPECIAL ASSESSMENTS: FULL OR FIRST HALF PAYMENT MUST BE PAID BY APRIL 30TH, OR ENTIRE AMOUNT BECOMES DUE, DELINQUENT AND SUBJECT TO INTEREST.

SURFACE WATER MANAGEMENT (SWM) (425) 388-6474: is a service charge, not a tax. Surface water fees are subject to the same exemptions for senior citizens and disabled persons. Late payments accrue interest at 12% per annum. Penalty of three percent (3%) is assessed on the total amount of current year service charge delinquent on June 1st. An additional penalty of seven percent (7%) is assessed on the total amount of current year service charge delinquent on December 1st.

SENIOR CITIZENS AND DISABLED PERSONS: If you own a residence or mobile home, are 61 years or older, or retired because of disability and had income in the previous year of \$35,000 or less, you may be entitled to a property tax exemption on your current tax. If you were retired two months of the prior year, that income may be averaged to qualify. Application forms and further information available through Snohomish County Assessor at (425) 388-3433. Up to three years additional taxes and a penalty of 100% of the additional tax may be assessed as specified in RCW 84.40.130 for not reporting promptly a change in your exemption status. (RCW 84.36.385)

PAYMENTS UNDER PROTEST: To preserve your right to seek a court ordered refund, you must comply with requirements of the law (RCW 84.68.020 and WAC 458.18.215). Copies available from the Treasurer's Office.
